**AGREEMENT AMENDING
 INTERLOCAL AGREEMENT ESTABLISHING DISTRICT COURT
 FILING FEES TO BE PAID BY THE CITY OF PALOUSE
 AND THE DISTRIBUTION OF FUNDS FROM FINES**

AGREEMENT by and between:

CITY OF PALOUSE, a municipal corporation organized under the laws of Washington, hereinafter "CITY",

and

WHITMAN COUNTY, a municipal corporation organized under the laws of Washington, hereinafter "COUNTY."

PREMISES:

- A. The parties entered into an Interlocal Agreement dated July 8, 1991, and August 26, 1991, whereby the CITY was authorized to file in the COUNTY District Court for adjudication criminal charges for alleged violations of the CITY's ordinances.
- B. Since August 26, 1991, the CITY has decriminalized its code, and all violations of CITY ordinances are now considered civil infractions. The parties now desire to amend the Interlocal Agreement to authorize the CITY to file citations in the COUNTY District Court for the adjudication of alleged violations of the CITY's ordinances that are civil infractions.

NOW, THEREFORE, in consideration of these premises, and in and for consideration of the benefits to be derived by the parties under the terms of this agreement, it is agreed:



The parties' above-described *Interlocal Agreement Establishing District Court Filing Fees to be Paid by the City of Palouse and Distribution of Funds from Fines*, dated July 8, 1991, and August 26, 1991, and recorded August 30, 1991, under Whitman County Auditor's No. 545620, is hereby amended to provide that, in addition to criminal actions, the CITY shall have authority to file citations in the COUNTY District Court for the adjudication of alleged violations of the CITY's ordinances that are civil infractions.

Except as amended by this agreement, the parties' above-described Interlocal Agreement is hereby reaffirmed and shall remain in full force and effect.
